Commission: RM929.4m rebate to be borned by utility firm

PUTRAJAYA: The Energy Commission (EC) says the RM929.37 million rebate to maintain the current electricity tariffs in Peninsular Malaysia and Sabah will be borned by Tenaga Nasional Bhd (TNB).

The RM929.37 million rebate, which works out to 1.80 sen per kilowatt-hour (kWh), is for the period of January 1 to June 30 this year.

The commission said it would be absorbed by TNB through an electricity supply system. "If you said the (rebate) is com-

ing from the government trea-sury, the answer is no. It comes from an electricity supply sys-tem, where TNB is the major player who operates on behalf of the government," said commission chairman Datuk Abdul Razak Abdul Majid at a media briefing, here, yesterday. The commission's acting chief
